#### CORNERSTONE EVANGELICAL PRESBYTERIAN CHURCH 9455 HILTON ROAD, BRIGHTON, MI 48114 CONGREGATIONAL MEETING SUNDAY, JUNE 11, 2023 – 12:15 PM SANCTUARY MODERATOR – PASTOR CHRISTOPHER A. WINANS

- 1. OPENING HYMN AND PRAYER Pastor Christopher Winans. Worship Director Don Nieman led the Congregation in the hymn "Great is Thy Faithfulness." Pastor Winans opened the annual June Congregational meeting in prayer at 12:14 pm, dedicating unto the Lord the church and its business. Cornerstone belongs to no man but is guided by the Holy Spirit. The Lord is the head of this church.
- 2. DECLARATION OF QUORUM (141 MEMBERS) Clerk of Session, Ruling Elder Mark Smith. A quorum was declared by Clerk of Session, Ruling Elder Mark Smith (191 members in attendance with 141 members required).
- 3. APPROVAL OF JANUARY 15, 2023 CONGREGATIONAL MEETING MINUTES Clerk of Session, Ruling Elder Mark Smith. Ruling Elder Mark Smith requested a motion to approve the January 15, 2023 Congregational Meeting Minutes. Ruling Elder David Schiavone moved and Member Alan Houtman seconded TO APPROVE THE MINUTES OF THE JANUARY 15, 2023 CONGREGATIONAL MEETING AS PRESENTED. A question was raised regarding the mention of the "Sidekick Ministry." Pastor Winans explained that this ministry is focused on partnering with special needs children (5<sup>th</sup> grade and under), thus allowing family members to attend church services and other activities on Sunday mornings. Director of Kids Ministry Vanessa Kerchaert added that ten children are currently covered, but we could use more volunteers. This opportunity to serve provides a great blessing. No further questions or comments were raised. Thus, Ruling Elder Mark Smith put the motion to approve the minutes to a vote. Motion carried.
- 4. REVIEW OF INDEPENDENT AUDITORS' REPORT DATED JUNE 30, 2022 Director of Finance Michael Machala. Director of Finance Mike Machala briefly reviewed the Independent Auditors' Report, noting that Cornerstone received the highest level of assurance that a church can obtain. This was summarized in the second paragraph of the report: "In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Cornerstone Evangelical Presbyterian Church as of June 30, 2022, and the change in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America."
- 5. OVERALL FINANCIAL RESULTS AND ATTENDANCE Director of Finance Michael Machala. Director of Finance Mike Machala reviewed Cornerstone's overall financial results from fiscal year 2018-2019 through today. The 2022-2023 estimate of income is

\$3,570,000 with expenses of \$3,585,000. Cornerstone will use its reserves to cover the projected \$15,000 deficit. This is the first time our church has seen a deficit. Giving is down from prior years, but Director of Finance Mike Machala explained this is often typical when a large capital project is underway. Some of the giving that normally supports operations lessened as people gave to the Shine Project. When the \$1,950,000 given to Shine is combined with our giving, Cornerstone received in excess of \$5,500,000 this year.

Director of Finance Mike Machala also reported that we have seen consistent growth in attendance over the last few years, with an estimate of 1,294 weekly attendees this fiscal year. Despite that, there has been a slight decrease in giving. Again, he reinforced that this is not unexpected due to the Shine Project. Importantly, all missions, all programmed activities and the church in Flint continued to receive the support that was committed. Clearly the Lord watches over our church and continues to bless Cornerstone.

Additionally, Director of Finance Mike Machala reported that we have cause to celebrate, as our current outstanding mortgage is approximately \$238,000 with plans to pay off the balance this summer. The congregation applauded at this news.

- 6. SHINE PROJECT UPDATE Pastor Christopher Winans. Pastor Winans reported that to date, we have commitments of \$6,661,000 for the Shine Project, with \$5,117,000 received to date. As could be expected, project costs have shifted upward from the initial 2020 estimates. We are working closely with Visioneering to sharpen our pencils. The latest proposal and Guaranteed Maximum Price (GMP) are due tomorrow, June 12, 2023. To that end, a Town Hall Meeting for Shine will be held on Monday June 19, 2023 at the church in the evening. Pastor Winans encouraged the congregation to attend that meeting for further details, questions and answers. He summarized that our hope is that we can quickly complete the planning and decide the next steps.
- 7. TERMS OF CALL FOR PASTORS GRIMM, TWEEDIE AND WINANS Ruling Elder Mark Smith. Ruling Elder Mark Smith requested that the pastors and their families step out of the sanctuary for this topic. He explained that Assistant Pastors are called by Session, but the Associate and Lead Pastors are called by the congregation. Their salaries and benefits have a significant impact on our budget, hence these terms of call are reviewed annually in this forum. Ruling Elder Mark Smith explained that the elements of the terms of call include base salary, housing allowance, health and disability, life insurance, retirement contributions, study allowances, ministry expenses, medical, dental and vision, as well as tuition discount at Cornerstone Christian School. He then presented the 2023-2024 recommendation, which proposed a 5% increase in salary and commensurate benefits for Pastors Grimm and Tweedie. Upon performing a national search of both EPC and non-EPC churches of our size, the data suggested that we increase Pastor Winans' salary and associated benefits by approximately 11% to place him in the mid-range. Pastor Winans is beloved by this church and we do not wish to run the risk of losing him.

Ruling Elder Mark Smith requested a motion to approve the terms of call as outlined. Trustee Tom Lampert moved and Inactive Elder Bill Garrett seconded **TO APPROVE THE 2023-2024 TERMS OF CALL FOR PASTORS GRIMM, TWEEDIE AND WINANS AS PRESENTED.** There was no discussion. **Motion carried.** 

8. REVIEW OF PROPOSED 2023/2024 BUDGET – Board of Trustees Chair Stephen Mahan and Executive Pastor Darrell Bozeman. Board of Trustees Chair Steve Mahan introduced himself and reminded the congregation that Cornerstone had instated a Board of Trustees approximately five years ago. He is humbled to walk in the footsteps of his predecessors Bob Clark and Dave Andrews. The Board of Trustees addresses the financial matters of the church. Executive Pastor Bozeman then reviewed the history of Cornerstone's tithes and offerings. Since 2011-2012, the annual giving request has increased by approximately However, in that same timeframe, inflation has increased by nearly 34%. Cornerstone has been diligently meeting its budget each year by analyzing retirement expenses, healthcare (which is still a gold plan), printers and even things such as coffee expenses (moving from 37 cents a cup to 9). Some costs cannot be controlled; for instance, phone expenses were unexpectedly raised from \$1000/month to \$5000/month. When Pastor Bozeman rhetorically inquired if the congregants' healthcare expenses had risen over the last twelve years, there were murmurs of agreement from the congregation. In light of this economy, the targeted giving request for the 2023-2024 budget has been raised by 4% to \$4,004,000. Planned expenses will be \$3,874,000, thus leaving a planned reserve of \$130,000. Pastor Bozeman stated that the 4% increase works out to approximately \$6 per week per attendee (equating it to the cost of a special coffee or large fast food sandwich). This budget will enable Cornerstone to continue to support all missions and programs at the same level, with slight increases in administration. We will still fund Flint and other church plants.

Clerk of Session, Ruling Elder Mark Smith then requested a motion to adopt the 2023-2024 budget. Member Mark Roberts moved and Ruling Elder Jim Proos seconded TO ADOPT THE 2023/2024 BUDGET WITH A GIVING TARGET OF \$4,004,00 AND A SPENDING TARGET OF \$3,874,000. Discussion ensued with Member Nancy Roesler inquiring whether the projected spending includes increased expenses due to the building expansion. Pastor Bozeman indicated that we will be holding reserves to address those. The new mortgage will likely go into effect the fall of 2025. Member Claudia Garrett asked for clarification on administrative costs versus salary and wages. The table presented includes all such costs as administrative, whereas the pie chart presented breaks down the details. Member Lisa Sybert inquired about the current mortgage; Director of Finance Mike Machala explained that the mortgage balance will be paid from the first draw of the Shine funding in order to lock in the interest rate. Member Jamie Nicholson cited the team for doing a thorough analysis and proposal. Former Trustee Phil Kofahl indicated that we were avoiding a pre-payment penalty on the mortgage. Director of Finance Mike Machala confirmed this, indicating that we are negotiating with the banker for the future mortgage and would like to waive the penalty. No further questions were posed. Ruling Elder Mark Smith called for the vote. Motion carried.

- **9. QUESTIONS & ANSWERS Pastor Christopher Winans.** There were no further questions or comments.
- **10. ADJOURNMENT.** Inactive Ruling Elder Jay Chamberlin moved and Ruling Elder Dan Forster seconded **TO ADJOURN THE JUNE 11, 2023 CONGREGATIONAL MEETING. Motion carried.** Pastor Winans closed in prayer, stating that though we love Cornerstone, it is hard to fathom that God loves the church even more. Pastor Winans asked for blessings upon each attendee. The meeting adjourned at 12:46 pm.


